

## TERMS OF USE AGREEMENT (Family)

In consideration for acceptance as customers by Braggame Rights of myself and the below listed minor children for whom I am the parent or legal guardian, I do:

- F. Declare that I have read, understood, and accept the following:
  - 1. I agree to pay any costs for gaming experiences and/or fees for Special Events I or my children sign up to play.
  - 2. I understand that I am at all times responsible for my own safety and that of my children when I or they participate at any gaming experience.
  - 3. I understand there could be a risk of medical problems (i.e., carpal tunnel, nerve damages, fatigue, eye strain, headaches, etc.) resulting from prolonged viewing of images on a TV screen or computer monitor and using game controllers, keyboards or other input devices. I expressly agree and promise to accept and assume all of the risks involved in gaming.
  - 4. I agree to pay any reasonable cost to repair or replace any Braggame Rights or sponsor equipment lost or damaged by myself or the above listed children through my/their actions, whether intentional, by accident or negligence. The determination of whether to replace or repair damaged equipment shall be made by the owner of such equipment (either Braggame Rights or sponsor). I will not be responsible for normal wear and tear on any equipment provided by Braggame Rights or sponsor.
  - 5. I understand and agree not to hold Braggame Rights., its officers, directors, employees, staff, or sponsors liable for any damages, theft or loss of any personal items brought to the establishment.
  - 6. To the fullest extent allowed by law, I agree to WAIVE, DISCHARGE CLAIMS, RELEASE FROM LIABILITY AND INDEMNIFY Braggame Rights., its officers, directors, employees, staff, or sponsors from any and all demands, causes of action, costs, expenses or obligations of any kind, known or unknown, on account of, or in any way resulting from, injuries and/or damages, even if caused by negligence by Braggame Rights., its officers, directors, employees, staff, or sponsors in any way connected to your gaming experience.
  - 7. I further agree to HOLD HARMLESS AND INDEMNIFY Braggame Rights., its officers, directors, employees, staff, or sponsors from any claims, damages, injuries or losses caused by my own negligence while a participant at Braggame Rights. I understand and intend that this assumption of risk and release is binding upon my heirs, executors, administrators and assigns, and includes any above listed minors.
  - 8. This agreement is intended to be as broad and inclusive as permitted by law, and may not be modified in any way. If a provision or any part of a provision of this Contract is held to be invalid or legally unenforceable for any reason, the remainder of this Contract shall not be affected thereby and shall remain valid and fully enforceable.

In signing this Membership Agreement/Release of Liability, I acknowledge that I have read this document in its entirety with full knowledge of its meaning and significance. I understand that this is a Legal Document, and I freely and voluntarily assume all risks, whether known or unknown.
